Daycare and Boarding Agreement:

Top Dog Daycare & Boarding, LLC agrees to exercise due diligence and reasonable care, and keep the premises clean, safe and properly enclosed. All dogs are handled or cared for by facility staff without liability of Top Dog Daycare & Boarding's part for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other animals or property by said pets, or from other unavoidable causes. Should any dog become ill or seem to be in need of medical attention, Top Dog reserves the right to administer aid and/or use any available veterinarian. Any expenses so incurred shall be paid by the owner of said dog in addition to other fees listed in this agreement. Owner agrees to pay the daycare/boarding rate in effect on the date the pet is checked into Top Dog. Prices are subject to change at any time without notice. No dogs will be released until all charges are paid in full. Late cancellation fees may also be applied for reservation cancelled within 24 hours of the said reservation. The facility shall have, and is hereby granted, a lien on dogs for any unpaid charges resulting from the services at Top Dog Daycare & Boarding LLC. Owner shall remain liable for complete bill as well as other charges incurred in the care and maintenance of said dog listed on this contract. It is expressly agree by the Owner and Top Dog, that Top Dog Daycare & Boarding's liability shall in no event exceed the lesser of the current tangible value of a dog of the same species or the sum of \$250.00 per animal. The owner further agrees to be solely responsible for any and all acts or behavior of said dog while in the care of Top Dog. The owner of the dog agrees to pay reasonable attorney fees incurred by Top Dog in the collections of any daycare services, boarding or other charges incurred by the Owner of the pet. The pet must be current on the following vaccinations; Distemper, Bordetella and Rabies. Valid proof of vaccinations must be presented before the dog can be dropped off. Owner agrees to maintain vaccinations and to keep Top Dog informed of any updates. Dogs arriving with fleas/ticks will be bathed at Owner's expense and may not be able to be in the daycare area. Top Dog reserves the right to refuse any dog. Owner agrees that the dog will be picked up by the owner or a pre-approved owner's agent by the designated pickup time, unless a prior extension is agreed upon prior to dropping off. Late charges will be executed if necessary. Owner agrees that their dog may be videotaped, photographed and recorded. Top Dog shall be the exclusive owner to the results and all proceeds of such tapings, photography, and recordings with the rights, throughout the world, an unlimited number of times in perpetuity, to copyright, to be used an to license to others in any manner. The owner further agrees that their dog may be used in any and all media and in promotion, advertising, sales, publicizing and exploitation of Top Dog Daycare & Boarding, LLC.
